COMMITTEE DESCRIPTION

Our Master Committees are responsible for organising events specifically for their respective (pre-)master. You will organise both formal events, such as in-house days and workshops, and informal events, such as socials and dinners. The goal is to create a strong community feeling within a master programme and to help students get in contact with companies and with each other. The Master Committees have much freedom to organise the events they feel are interesting for their respective master. Thereby, you will be creative, will have much responsibility, and will work together. Since you will also organise formal events, you will get in contact with many companies. Furthermore, there are possibilities to organise seminars, with which you can gain experience in contacting speakers. And by organising informal events, you will help fellow students to get to know each other and build a strong social network! Optional:

- External relations: responsible for all company contacts & acquisition.
- Promotion: responsible for all promotion of MC events
- Secretary: responsible for the MC email, contact with individual master students.

Workload: 1-5 hours a week, depending on the events you choose to organise.


